With all due respect I want to let you know that, I am Yasmin Choudhury, father: Late Alhaj Abdul Mukit Choudhury, Vill: Choudhury Bangla, Alinagar, U/P: Alinagar, Police station: Beanibazar, Dist: Sylhet. I am a British Citizen with no visa required for Bangladesh. My UK passport number is [REDACTED]. I am seeking protection from my family members named 1. **Saleh Ahmed Khasru**, father: Unknown, Present address: Alinagar, U/P: Alinagar, Police station: Beanibazar, Dist: Sylhet, Profession: Local Politician-BNP, 2. **Enamul Haque Choudhury**, Father: Late Abdul Khaliq Choudhury, present address: Alinagar, U/P: Alinagar, Police station: Beanibazar, Dist: Sylhet, Permanent address: [REDACTED], Profession: Director of Sylhet Meat Club & Paragon Property Ltd. 3. **Faisal Ahmed Choudhury**, Father: Late Abdul Mummit Choudhury, Present address: Alinagar, U/P: Alinagar, Police station: Beanibazar, Dist: Sylhet, Permanent address: Shubid [REDACTED], Profession: Chairman, Baraka Power also he is British citizen 4. [REDACTED] father: Late Abdul Mummit Choudhury, Permanent address: [REDACTED], Present address: Alinagar, U/P: Alinagar, Police station: Beanibazar, Dist: Sylhet, Profession: MD, Baraka Power also he is British citizen. I believe I am in Danger because I have reported **Saleh Ahmed khasru** for sexually assaulting me in 2019 the GD reference number is Kotwali PS - 715/22, these male cousins of mine, are extremely threatening and disrespectful to women like me. I have complained before to Bangladesh police and British Police about the bullying, domestic abuse and fraudulent behavior of even my brother, mother, elder sister who, is a British solicitor. Yet no action was taken in 2015 by British Police. In 2015 many of my blood family had also destroyed my **LOVEDESH** and **Amariza Foundation** charity projects in Ambarkhana Sylhet and in my village Alinagar and my own brother has physically assaulted me in UK and in summer 2015 during Ramadan my sister and my mother made me and my child daughter Amber Choudhury- Kaye(age-13) homeless. I have informed nearly all of my male cousins about Saleh Ahmed Khasru sexually assaulting me. They did not help me instead Saleh Ahmed Khasru, one of my male cousin that I was lying. None of my cousins took any action. I believe my blood family are so dangerous, that they are taking steps to protect Saleh Ahmed Khasru. I possess evidence that many of my male and female relatives are protecting Saleh Ahmed Khasru and refuse to help me or keep me safe, as I have many photographs of them attending a boat trip with Saleh Ahmed Khasru in November 2021 even after informing them of the crime done to my body. And this is why I think my family may assassinate me or harm me or my staff because they are also all involved in undertaking a development project in our village with Saleh Ahmed Khasru and having reported to Bangladesh Police of the sexual assault crime by Saleh Ahmed Khasru on 7<sup>th</sup> July 2022. This is why I am in danger.

I therefore pray and hope that you would be kind enough to accept my application of doing a General Diary in your Police Station.
